 - 1.06.c. Conflicts of Interest

Following further discussion, Ms. Quinlan moved, seconded by Mr. Barnett, to offer a consent agreement that stipulates the following:

- The professional's license shall be placed on probation for 24 months
- The professional shall receive clinical supervision monthly from a pre-approved independently licensed behavioral health professional for 24 months
- Early release available after 12 months at the recommendation of the clinical supervisor
- Clinical supervision shall focus on professional boundaries, transference, dual relationships, and documentation
- The professional shall complete 6 clock hours of the NASW Staying Out of Trouble course or its pre-approved equivalent
- The professional shall complete a pre-approved 3 semester credit hour graduate level course in behavioral health ethics

and if not signed, to invite the professional to participate in a formal interview and, if not accepted to remand the matter to a formal hearing. The motion passed unanimously. Ms. Bailey recused.
